

# Livingston County Fairgrounds Total Solar Eclipse Craft & Vendor Show

Concession stands will be operating for food/drink purchases. Event will be advertised in local penny saver and multiple social media sites.

3. Any vendor bringing children will be responsible for them. Vendor **will not** allow children to run around unsupervised, distract or disrupt other vendor or potential customers at other vendor areas.
  4. No loud distracting music, noise, and or sound amplification devices used by Vendor at the above-mentioned Event.
  5. Vendor will have access to the location up to 6pm post Event conclusion to dismantle/remove all items brought to the Event by Vendor. Vendor shall leave the location free from trash and in similar condition that it was in before the Vendor was there.
  6. Vendor agrees to hold the Event Organizer, Livingston County Agricultural Society & Fair at Caledonia and the Village of Caledonia, free from any damages or claims that may develop in connection with participating in the above-mentioned Event.
